Meeting called to order at 1:00 P.M. by Commodore Skip Maniscalco

Opening Comments (Commodore Skip Maniscalco)

Treasurer's Report

It is imperative that all checks are turned in to Treasurer Donna Ryan immediately after the sail. (Boats are rented on a sailing club debit card that takes money immediately from the account.)

Membership Report

Members have complained about not receiving mass mailing such as "E-Blast" announcements. Discussion pursued. This is a Google software glitch that occasionally occurs in mass mailings.

Provision in the anticipated amount of \$50.00 will be made in the O.H.S.C. budget for additional Fiesta party costs.

Other Business:

Held discussion on scheduling, cancellation, condition of boats. Fleet Captain indicated Captain Scott Barnard was looking into identifying possible alternatives for boat rentals by OHSC. He also described HIYC follow up to boat deficiencies submitted by OHSC following sails. Boats must be cancelled no later than 72 hours prior to scheduled rental except in case of unpredicted adverse weather conditions, e.g., thunderstorms, lightning, heavy rain, etc. No sails will be scheduled in March, April, May or June. It will be up to Captains to ascertain boat availability and to lock in, if necessary, as close to the sail date as possible or, otherwise, to show up on the sail date and rent on the spot. For cycle 3 and cycle 4 sails, Fleet Captain will submit scheduled sails to HIYC. HIYC will reserve boats according to the schedule, subject to the 72-hour cancellation notice requirement.
