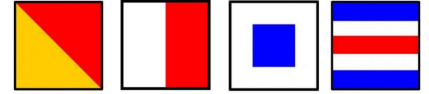

I, legal guardian of minor guest _____ understand that participation in OHCC sailing activities involves the risk of personal injury, including death. I also understand that participation in this activity requires participants to follow instructions and abide by all applicable rules (including wearing a provided U.S. Coast Guard-approved personal flotation device at all times while aboard the boat) and standards of conduct. I understand this outing may include sailing on the ocean as well as San Diego Bay, participating in basic sailing maneuvers and possibly getting wet.

In case of an emergency involving my child, I understand efforts will be made to contact me. In case I cannot be reached, permission is hereby given to the medical provider to secure proper treatment, including hospitalization, anesthesia, surgery or injections of medication for my child. Medical providers are authorized disclosure of protected health information to the adult in charge and/or any physician or health-care provider involved in providing medical care to the participant.

With appreciation of the dangers and risks associated with this activity, including preparations for and transportation to and from this activity, on my own behalf and/or behalf of my child, I hereby fully and completely **release, waive and discharge** any and all claims for personal injury, death, or loss that may arise against the Ocean Hills Country Club Homeowners Assn., its members, directors, officers, representatives, administrators, agents, partners, employees, contractors, insurers, attorneys, Ocean Hills Country Club Sailing Club, Harbor Island Yacht Club, captains, first mates, volunteers, residents, guests or any related parties associated with the activity from any and all liability based on or arising out of or occurring in connection with this activity, including failure of personal flotation devices or any other life-saving equipment available to captain, mate, mates and passengers engaged in the activity.

I hereby agree to **indemnify and hold harmless** the Ocean Hills Country Club Homeowners Assn., its members, directors, officers, representatives, administrators, agents, partners, employees, contractors, insurers, attorneys, Ocean Hills Country Club Sailing Club, Harbor Island Yacht Club, captains, first mates, volunteers, residents, guests or any related parties **from any and all claims, damages, actions, causes of action, liabilities, losses, costs, attorneys' fees and any other expenses** based on or arising out of or in connection with this activity.
